2. No refund after closing date without vet or doctor's certificate within 14 days.
3. Competitors must compete at their assessed 3PE level
4. Riders must supply their own bridle or saddle cloth numbers and worn on both sides of the horse.
5. Registered club colors and approved helmets and riding boots must be worn at all times.
6. Riders must present to gear check 20 mins prior to dressage and obstacle event
7. Competitors must wear arm bands for phases 2 & 3
8. Protests must be lodged within 30 minutes of interim scores posted. Accompanied by \$20 refundable fee.
9. Ground Jury's decision is final, and no secondary protests will be entered into.
10. SDSJ Club Inc. does not accept any liability for accident, injury, illness, damage or loss to any person, horse, or property.
11. The Committee reserves the right to cancel classes or otherwise amend the program. If classes are cancelled a full refund will be made.
12. If medical attention is deemed necessary, an ambulance will be called at the cost of the injured party.
